Public rights of way – Barnet Borough Council**

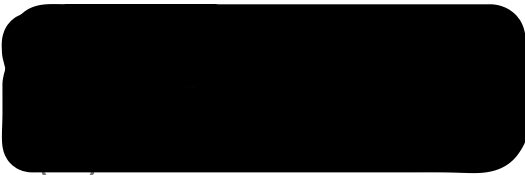

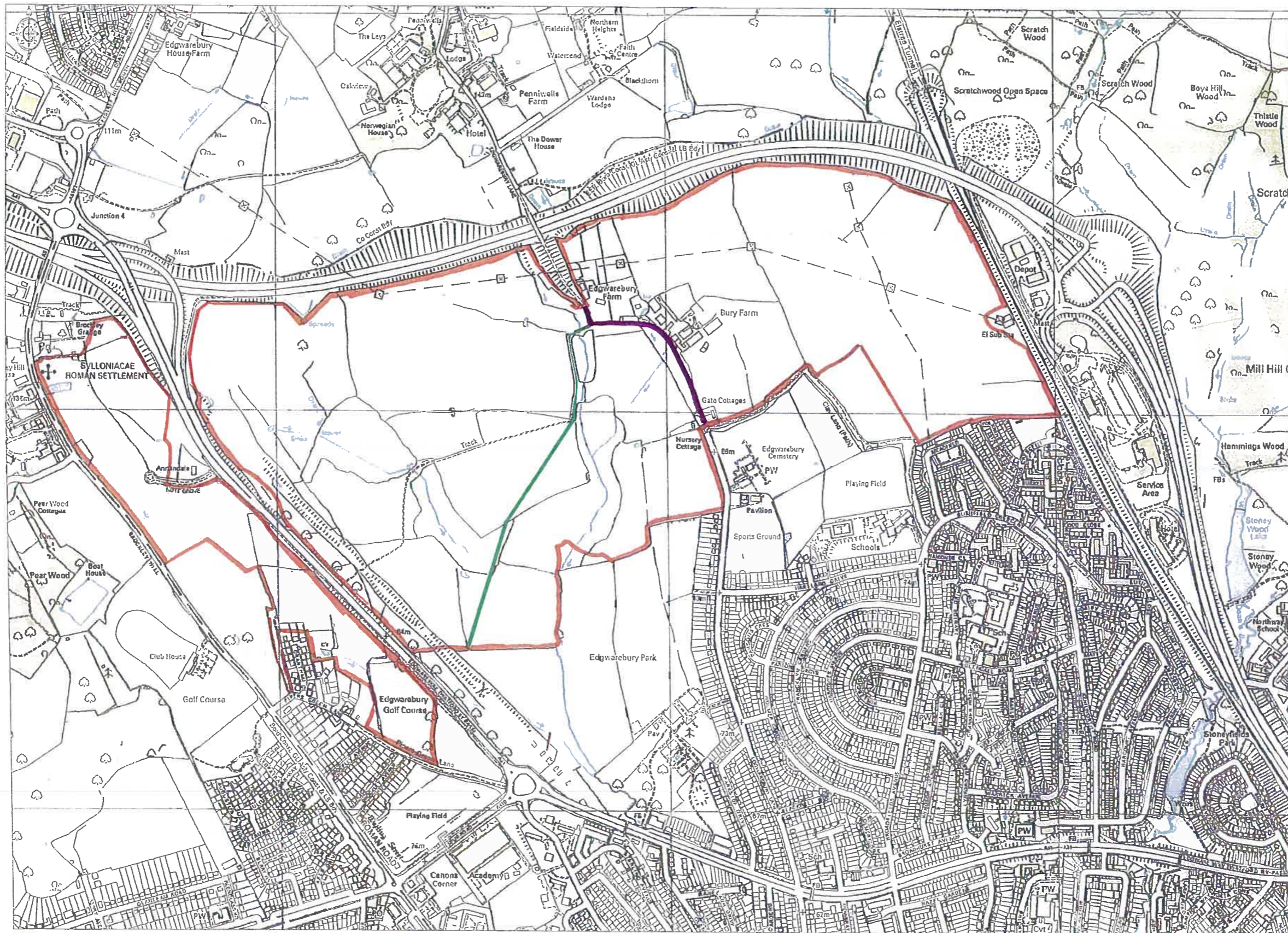
