NOTICE OF MAKING A STOPPING UP ORDER

SECTION 247 TOWN AND COUNTRY PLANNING ACT 1990

NOTICE is hereby given that the London Borough of Barnet (“the Council”) acting in its capacity as local highway authority has made an Order on 6 February 2020 under section 247 of the Town and Country Planning Act 1990 (as amended) (“the Act”) authorising the stopping up of the highways described in the Schedule below and shown hatched with thick black diagonal lines on Drawing No. 23624002-STR-HGN-100-DR-D-01002 Rev P4 attached to the Order.

The Order will enable the regeneration at Brent Cross, Cricklewood to be carried out in accordance with planning permissions granted under Part III of the Act by the Council under reference numbers 18/6645/FUL, 18/6409/RMA, 17/6662/RMA and 19/2291/FUL, and will be for no other purpose.

COPIES OF THE ORDER AND RELEVANT PLAN MAY BE INSPECTED and/ or obtained free of charge between the hours of 9.00am and 4.30pm Monday to Friday at the Main Reception, 2 Bristol Avenue, Colindale, London NW9 4EW.

Any person aggrieved by the making of the Order and desiring to question the validity of the Order (or of any provision contained therein) on the ground that the Order is not within the powers of the above Act or that any requirement of that Act or of any regulation made under the Act has not been complied with in relation to the Order, may, within 6 weeks from the date of the Order apply to the High Court for supervision or quashing of the Order or of any provisions contained therein.

THIS NOTICE is given by virtue of Section 252 of the Act.
